Job Description:

Under general supervision, the successful candidate will perform regulatory compliance work of considerable difficulty as a member of the Natural Gas Unit in the application of Commission rules/policies, state/federal laws and the development of recommendations in matters concerning the regulation of Natural Gas Utilities, Municipal Gas Companies, and Natural Gas Marketers.

Duties and Responsibilities/Technical Skills:

The Natural Gas Candidate will conduct independent analyses on a wide range of issues related to natural gas utility ratemaking, capacity supply planning, gas supply planning, alternative ratemaking treatment, auditing of Natural Gas Utility's construction program's financial activity, auditing of the purchased gas adjustment financial records, auditing of the manufactured natural gas plant remediation expenditures, and review of the cost allocation manuals of the Natural Gas Marketers with an electric affiliate. The Natural Gas Candidate also will review and evaluate a range of issues regarding Natural Gas Marketers' deregulation operations and this includes, but is not limited to, the periodic review of financial data and the review of new applicant's financial and technical capability to enter the natural gas deregulated market. The Natural Gas Candidate must apply critical thinking and analytical skills co-mingled with engineering/financial knowledge and/or natural gas regulatory practices and standards related to accounting, finance and economics. The Natural Gas Candidate must develop a good working knowledge of the Georgia Statutes that governs the regulation of the state natural gas industry. The Natural gas candidate must develop a good working knowledge of the natural gas industry and how this affects Georgia, including impacts from decisions made at the Federal Energy Regulatory Commission (FERC).

Other Skills:

The Natural Gas candidate should demonstrate both leadership and team building skills, and be willing to establish and maintain collaborative working relationships with state government and industry officials. The Natural Gas Candidate must be able to multi-task and shift priorities as needed on assigned multiple projects. The Natural Gas Candidate must have a good command of verbal and written technical communications.

Minimum Training, Experience, Skills and Abilities:

Minimum Training, Experience, Skills and Abilities: Completion of a bachelor's degree or graduate degree in accounting, finance, economics, mathematics, or related field. Excellent oral and written communication skills.

Preferred Qualifications

One or more of the following: Completion of a graduate degree in accounting, finance, economics, public policy or related field; or professional work experience in utility regulatory ratemaking, accounting or economics; certification as a CPA/CFA, 3 to 5 years of regulatory experience in a comparable field.
